TERMS & CONDITIONS OF THE CONTRACT

(A) **APPLYING FOR A PASS:** All applicants are subject to approval. (i) Proof of birthdate must be shown when seeking age-based discounts. (ii) **2021-2022 "No Questions Asked Refund Policy"**. We will fully refund, (this will include all taxes and fees paid) no questions asked, for your Season Pass purchase up to **October 1, 2021**. (B) **USE OF THE PASS** (i) The holder of a valid season pass is permitted to use all lifts in operation during regular operating times. (ii) A valid season pass must be worn at all times when accessing lifts and must be clearly visible to the lift operator. (iii) If a Passholder is not able to produce his/her pass, that individual will be required to purchase a regular lift ticket at the regular price. No refund will be issued. (iv) A fee of (\$30 + GST) will be assessed for replacement of a season pass identification card, if lost. (v) **"Guaranteed Minimum Operating Day Policy"**. Your Season Pass for the 2021-2022 season has a Guaranteed Minimum amount of 50 Operating days. For every operating day less than 50, you will be credited with 2%, (up to 76%). This credit can go towards the purchase of your 2022-2023 Season Pass. Refunds will not be issued in cases of cancellation of operations due to weather conditions or mechanical failure of equipment. (vi) A Season Pass expires on the 30th day of April of each year. (C) **RESTRICTIONS:** (i) This pass is the property of My Recreational Mountain Co-operative, is for personal use and is non-refundable and non-transferable. (ii) Should a pass be found on a person other than the authorized passholder, both owner and user will be expelled from Shames Mountain and the pass will be revoked without refund. (iii) Each passholder agrees he/she will not teach skiing/snowboarding or telemark skiing for remuneration on lands owned or controlled by My Recreational Mountain Cooperative. (iv) Season pass cards remain the property of My Recreational Mountain Cooperative and must be returned upon request. (v) The Season Pass Card may be revoked for misconduct or breach of the Alpine Responsibility Code. **NOTE:** A Family is 1 Adult Parent/Legal Guardian(s) and a dependant (20yrs or younger) residing in 1 household.

The applicant herein acknowledges he/she is required to sign PRIOR to PURCHASE the 'Release of Liability, Waiver of Claims, Assumptions of Risks and Indemnity Agreement' and further, that by signing this document, he/she waives certain legal rights, including the right to sue. IMPORTANT: Parent/Legal Guardian must sign for all minor passholders (those under the age of 19 years) PRIOR to PURCHASE being made.
